Preliminary Takeaways

- Continue to encourage permanent identifiers (DOIs) for NOAA archival datasets
- Encourage consistency in developing data management plans
- Encourage automation where possible on tracking metrics for EDMC activities
- Begin to encourage thinking about including science software, e.g. models as part of 'data'
- DAARWG still looking at the CLASS and GOES-R archiving requirements
