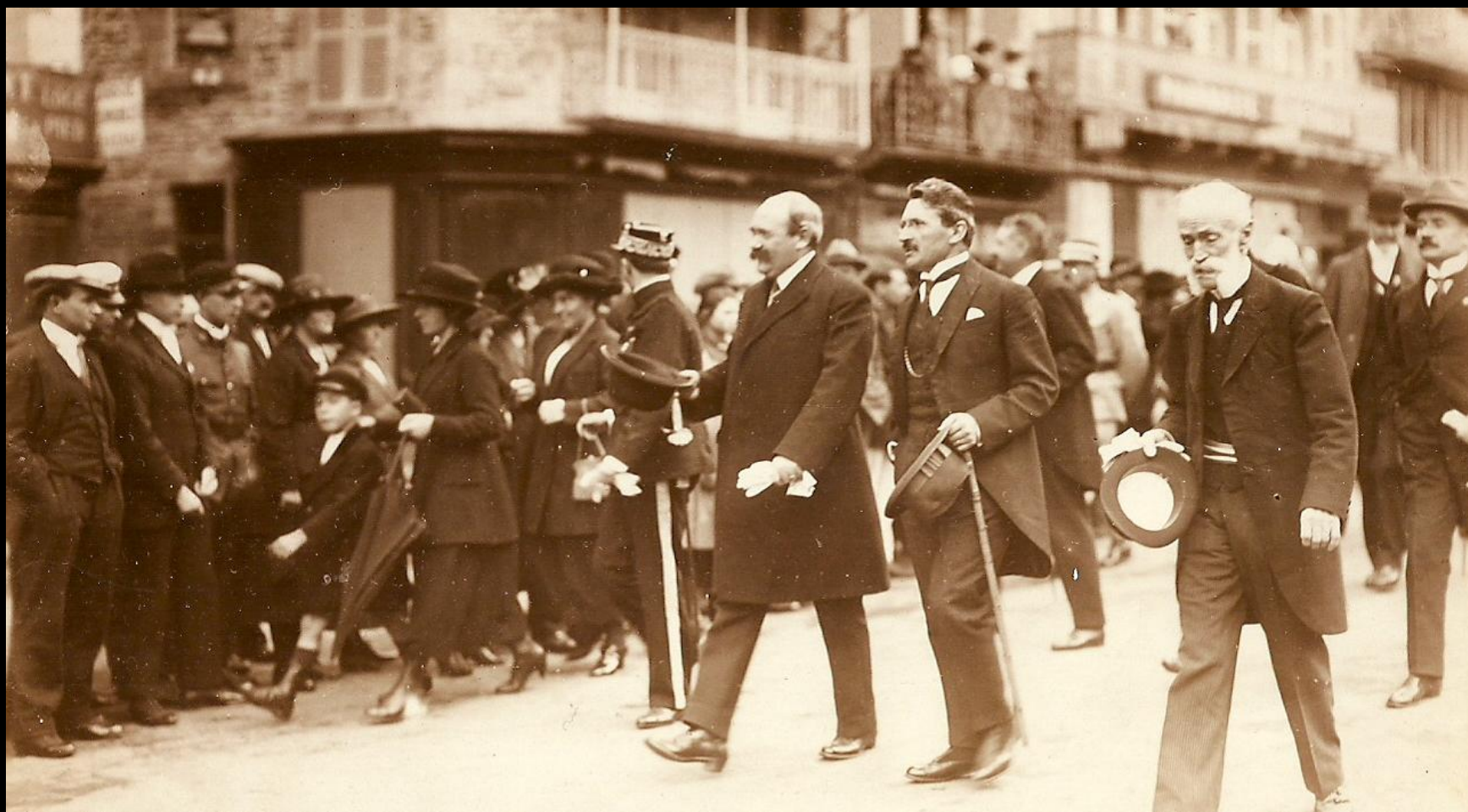

Seize the Arctic: time is right. Does the US have the assets to do this and if so how quickly could we mount an exploration?

# Some Major Findings

- Strong community support for a coordinated, collaborative national program of ocean exploration that combines the public and private sectors.
- Strong community support for NOAA to play the leadership role it has been authorized to play in PL 111-11.
- Strong community endorsement of the present NOAA ocean exploration model:
  - Dedicated platform
  - Ships of opportunity
  - AUVs, ROVs, and less emphasis on HOVs
  - Telepresence
  - Data sharing on a timely basis
  - Public engagement

# Some Major Findings

- Strong community endorsement that priorities should be set by the ocean exploration community, but recognizing National Priorities.
- Initial priorities included places and processes:
  - Arctic, Western Pacific
  - water column
  - ocean acidification
- Strong consensus that it is not NOAA's responsibility to be a major developer of new technologies, but that it needs to be a leader as an early adopter, providing validation, setting standards.

# Some Major Findings

- Citizen Science
  - *New and important*
  - *Participation and contribution will continue to grow*
- Data Sharing
  - *Free and open (mostly)*
  - *Need for data synthesis of contemporary and historical data*
- Public Engagement
  - *Draw in public with a positive message*
  - *Need for more effective communications strategies*
  - *Opportunities to participate (actively) are important*

# 3 Important Points

- The Ocean Exploration 2020 Forum (July 2013) was a community statement of more than 110 of the nation's leading ocean explorers of the qualities they wanted a national program to have.
- The OEAB is being stood up in response to the Ocean Exploration Act and the Gaffney/Ausubel Decadal Review recommendations.
- SAB is waiting for NOAA's Response to the Decadal Review of OER.

- SAB convenes a conference call by mid-December with OEAG and NOAA Leadership to be briefed on NOAA's Response to the Gaffney-Ausubel Decadal Review of OER.

# *After Ocean Exploration 2020*

- The President's Panel Report (2000) called for a national ocean exploration program and a national forum as a venue for ocean explorers to share and exchange ideas
- The Ocean Exploration Act of 2009 requires NOAA to coordinate a national program and to host a national forum
- The NOAA Ocean Exploration Decadal Review (2012) called for a forum as soon as possible
- The OEAB is being stood up in response to the Ocean Exploration Act and the Gaffney/Ausubel Recommendations.
