  - Local and regional implementation

## Sea Grant and NOAA



- Over **300 universities** provide access to oceans, coasts and Great Lakes R&D assets
- Stable national infrastructure of **600 university employees, 3,000 scientists, coastal experts, educators and students**
- Support for **350-400 research projects** annually and **900 graduate students**
- Connects **4500+ partner organizations** each year




## **Response to 2012 Recommendations**



1. ...continue to advance national priorities and solve problems on a local/regional basis, with sensitivity to local needs.
  - Strategic Plan for 2014-2017 shows positive and effective Sea Grant attention to this recommendation.
  
2. ...continue to track and report the impacts of Sea Grant activities.
  - Planning, Implementation and Evaluation Resource (PIER) database provides support and guidance on effective impacts. Refined 2014-2017 program measures and metrics.

## Response to 2012 Recommendations



3. ...continue to emphasize partnerships and collaborative efforts.

- Partnerships are growing in number and impact. They increase Sea Grant's scope of influence and leverage support for wider efforts.

4. The federal budget should allocate more resources to reverse the erosion of buying power and maintain a dynamic program.

- FY 2014 Sea Grant increase of ~ \$5M: welcome recognition of the value of the services rendered by Sea Grant.


## **Response to 2012 Recommendations**



5. The National Sea Grant Office should review the funding structure of Sea Grant.
  - A third Advisory Board Allocation Committee challenged historic practices of Sea Grant funding. NSGO has begun to rebalance for a minimum level of base funding of \$1M.
6. NOAA should continue integration of its coastal programs.
  - Good progress: improving delivery of services to NOAA partners and customers and creating opportunities for further coordination and collaboration across NOAA.




## **Summary Findings**

Sea Grant is an effective and solid investment of public monies in responding to the needs of coastal and Great Lakes communities.

- Focus Area impacts
- Sea Grant in Action response to real needs


In a full cycle of the PIE process, all programs were found to meet or exceed expectations.

Sea Grant has made great strides in addressing the allocation needs of the state programs through rebalancing of funding.



## Challenges

- While the 0.5% administrative cap increase in the Senate committee reauthorization is welcome, the Board supports removal of the cap.
- The FY2014 budget allowed an increase in base funding for several underfunded programs, while retaining existing funding for others. Continued increases will return Sea Grant to a level that strengthens its ability to meet the needs of coastal communities.
- Federal consolidation of education programs threatens the integrity of the program's critical mission and its workforce development. Education is part of Sea Grant.



## ***State of Sea Grant 2014 Report***

### **Recommendations (page 26)**

1. Continue to focus on advancing national priorities while solving problems on a local and regional basis. Continue to emphasize partnerships and collaborations.
2. Continue tracking and reporting of the impacts of Sea Grant activities toward the achievement of national goals.
3. Continued viability of Sea Grant relies on adjustment of budget equity among programs, while maintaining program review and merit considerations.
4. Strengthen the focus area in Environmental Literacy and Workforce Development.
