  - EPIC- monitoring evolution and awaiting emission of the RFP and final strategic plan
- Collaboration with SAB's CWG on assessing NOAA's Precipitation Prediction Grand Challenge strategy

#### **Activities since December 2019 SAB meeting**

- In-person meeting in Norman, OK, January 28-29 discussed EPIC, Report to Congress, membership, S2S report, HFIP report
- Virtual meeting March 2 discussed EPIC, membership, Report to Congress, and HFIP report
- Received NOAA response to August EPIC report, OSSE report, and TWFIP report
- Met with SAB's Climate Working Group to discuss collaboration on assessing NOAA's Precipitation Prediction Grand Challenge strategy

#### **Future**

- Continue EPIC conversation and communicate when deemed valuable
  - Explore idea of cross assignment of members on tiger teams between EISWG and CWG
- June 2020 in-person EISWG meeting, location TBD
- EISWG annual report to Congress draft in progress and will be sent to SAB in late-spring 2020
- Expecting to get the final S2S report from NOAA
- Review of NOAA report on Hurricane Forecast Improvement Program, possibly with recommendations, to SAB mid-year 2020
