#### **Summary of Recommendation Response**

 In Nov 2022, the DAARWG stated their support for NCEI's plan to use commercial cloud resources within the NCCF for the next-generation archive and provided seven specific observations and concerns NESDIS agrees with the concerns, provided a detailed response to each, and welcomes the opportunity for more routine interactions with the DAARWG



#### **NOAA Actions in Response to Report**

- Clarified terminology following Open Archival Information System (OAIS) Reference Model, the ISO standard for digital archives (ISO 14721) and named the new cloud archive system: Open Information Stewardship Service (OISS)
- Refined two-year cloud archive development and migration plan
  - Developing metrics to measure and track cost performance
  - Formalizing AWS "exit strategy" involving NOAA Cloud Utility BPA provision
  - Working with CEOS on STAC best practices for eventual NCCF implementation
  - Developing a data optimization strategy and updating NCEI netCDF Templates for cloud considerations
  - Tracking emerging NOAA Open Source Software policy for eventual sharing of code from the NCCF (but not for the NCCF Infrastructure-as-Code itself)



### **Challenges/Opportunities**

- Once-in-a-career opportunity to build a "Web 3.0" archive from first-principles with a knowledge graph at its core, enabling semantic interoperability, scientific reproducibility, linked open data, and AI/Digital Earth Twins
  - Leveraging the community (e.g., ESIP, AGU Informatics, CEOS) and DAARWG to stay on course



# Path Forward and Future Engagement with the SAB


- SAB/DAARWG More frequent and routine interactions can be useful to help prioritize and track as we navigate the rapidly evolving landscape
